Those families with eligibility for Camps and School Excursion Funding (CSEF funding) can utilise this support for these costs. Information about eligibility for CSEF and for which school things it can be used can be found using your Compass login under the Community menu in School Documentation. Please contact the Office if you require more information.

Please note if you have previously applied for and received CSEF funding for a specific child, you don't need to apply for 2023 funds. Your application and allocation of funds will automatically be processed in 2023, as long as your family is still eligible. It is important to note, however that if you have a new child starting school for the first time in 2023 you will need to apply for 2023 funding for that child.

Payment methods

CompassPay

Ferntree Gully North Primary School uses the communication platform, Compass for attendance, excursions, incursions, camps and course confirmation and payment. Families may continue to make multiple contributions throughout the year in manageable amounts should you wish to and we can offer a variety of ways you can do this through Compass Pay.

Credit card payments via Compass is our preferred method of payment however Bpay remains a payment option and all family Bpay reference numbers remain the same as 2022. Should you require a copy of your statement showing your Bpay reference, please contact the office.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy and any other relevant information.

Student Supplies

If you would like to make a contribution for 2023 this year, student book packs will be available for collection from Thursday 1st December. <u>ALL</u> students starting in grades 1 to 6 for 2023 will receive their book packs no later than the first day of school Monday 30th January 2023. All Preps starting in 2023 will receive their supplies when they start school in 2023.

CAMPS SPORTS & EXCURSION FUND INFORMATION

The Camps, Sports and Excursions Fund (CSEF) will provide payments for eligible students to attend camps, sports and excursions.

Families holding a valid means-tested concession card or temporary foster parents are eligible to apply. \$125 per year is paid for eligible primary school students, with \$225 per year paid for eligible secondary school students. Payments are made directly to the school and are tied to the student.

In 2023 the program will again be promoted to families via school newsletters and websites.

To be eligible for the fund, a parent or legal guardian of a student attending a registered Government or non-government Victorian primary or secondary school must:

- a) Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be the holder of a Veterans
 Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- b) Be a temporary foster parent, and;
- c) Submit an application to the school by the due date.

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

CSEF eligibility will be subject to the parent/legal guardian's concession card successfully validating with Centrelink on either the first day of term two or term three.

The amount payable for eligible primary and secondary students is:

- \$125 for Primary school students.
- \$225 for Secondary school students.

CSEF payments are for the application year and cannot be claimed retrospectively for prior years.

The CSEF system only allows one application per student. Parents in shared custody situations are encouraged to make decisions as to who applies for the CSEF. Schools should not be put into the position of arbitrating in decisions such as this.

If the parents cannot decide between themselves who should apply, they should be encouraged to resolve the dispute through the Family Court, or contact the Department's CSEF Helpdesk for more information on Ph: 1800 060 970.

Schools are required to use the Camps, Sports and Excursions Fund (CSEF) payment for expenses relating to Camps, Sport and/or Excursions for the benefit of the eligible student. Some common examples of school-organised programs for which the CSEF payment may be used include:

- School camps/trips
- Swimming and other school-organised sporting programs
- Outdoor education programs
- Excursions/incursions

The CSEF payment cannot be used towards voluntary school charges, nor towards books, stationery, school uniforms, before/after school care, music lessons, school graduations or productions etc.
